

<u>Comments</u>: There is pine pollen (yellow film) on the surface of many of the ponds. **One small four-foot gator observed in pond 8**. We could use some rain. I predict more weed growth with abnormally warm weather.

#### Lake 4: Rated: 9

- Pond is dark green from planktonic algae.
- Minimal film on the surface.
- No alligators observed.



<u>Treatment</u>: None needed. <u>Recommendations</u>: Keep an eye out for gators.

#### Lake 5: Rated: 10

- No weeds
- Water level is low.



<u>Treatment</u>: None needed. <u>Recommendations</u>: Keep a lookout for gators.

### Lake V-2: Rated: 6

• Heavy growth of chara, moderate naiad, minimal torpedo grass.



**<u>Treatment</u>**: I launched the airboat and treated the chara and naiad aggressively. **<u>Recommendations</u>**: Keep a lookout for gators.

## Lake 6: Rated: 7

• Moderate floating algae and pennywort around perimeter.



**<u>Treatment</u>**: I launched the airboat and treated the algae and pennywort. **<u>Recommendations</u>**: May need a couple more grass carp.

### Lake 7: Rated: 7

- Moderate spikerush and bladderwort along the edge.
- Minor torpedo grass.



**<u>Treatment</u>**: I treated the spikerush and bladderwort by backpack. **<u>Recommendations</u>**: Keep a lookout for gators.

#### Lake 9: Rated: 9

• Minor grasses and bacopa.



**Treatment:** I hand raked some of the heavier weed areas. **Recommendations:** Keep a lookout for gators.

## Lake 8: Rated: 9

- Minor shoreline grasses.
- Four foot gator in pond.



<u>Treatment</u>: None needed. <u>Recommendations</u>: Have gator removed.
